their medical needs: on the phone, via telehealth or at Grace for
necessary or urgent medical care. We launched a telehealth patient
appointment option at the onset of the pandemic and provided 1,547

telehealth appointments. When some patients needed immediate access to food but were fearful to leave their home, we arranged drive-by food pick-up or we delivered food to their house. A staff doctor or nurse attended many deliveries to check on the patient, drop off medication, or provide follow-up care. While we are back to full capacity following all CDC safety protocols, the need for Grace has never been greater. In 2020, our already vulnerable patients were thrust into survival mode and many continue to experience medical or economic hardship.
